Additional amenities will open June 11th with safety protocols in place.

- All opened amenities and facilities will have capacity limitations of a maximum of 50 people if space allows to properly distance.
- Masks are required in all indoor locations.
- Activity Cards are required with periodic checks.
- At this time, no guests are permitted.
- All residents will be responsible for their own personal safety and for compliance with the safety protocols for each location.
- Residents should bring their own hand sanitizer and wipes in the event that OTOW provided sanitizer is out.

Do not utilize the facility/amenity if, within the past 14 days, you have had Covid-19 symptoms, have been in contact with or exposed to a person having Covid-19, have been asked to self-monitor at home, have been on a cruise or traveled to any U.S. city or foreign country on the CDC's affected areas of widespread/sustained community transmission including but not limited to New York, New Jersey, and Connecticut.

Any violation of the posted amenity rules may result in the amenity closing. Disrespect of employees enforcing amenity rules will not be tolerated and will result in loss of privileges.

Activities Manager, Nancy Rogers will work with card players and poker groups to develop safety protocols to allow play as soon as measures can be put in place. Amenity openings / changes for Wednesday, June 10th include: (unless noted here, all previous restrictions remain in place)

East and West Activity Centers and Pools

- Both the East and West Activity Centers and pools will now be open from 7:00am to 2:00 with safety protocols in place as listed above
- Lobby restrooms at each center will remain closed at this time
- The Good Karma Café and Learning Lab will remain closed at this time
- Sauna and showers will remain closed
- Hot tub will open with a maximum of two permitted at a time
- No long term reoccurring activities/meeting reservations will be taken at this time

See Nancy Rogers to schedule activities/events for no more than two-weeks in advance

• The Woodshop and Lapidary will remain closed

Outdoor Amenities including Pavilion and grill areas

- Use of grills is permitted and can be scheduled through Nancy Rogers
- Residents are restricted from brings grills or furniture from home

Tennis and Pickleball, Shuffleboard, Horseshoes

- The Tennis "dug-out" will be open for seating with proper social distancing maintained
- Residents may not bring chairs
- No regular scheduled club play is permitted at this time
- No league or tournament play is permitted at this time

Golf

- Open normal operating hours with safety protocols in place as outlined above
- The pro shop will open
- Restrooms will be open and residents are encouraged to use disinfectant provided
- Cart rentals are permitted for single riders or 2 persons residing in the same unit
- All previous restrictions remain in place

Fitness Center

- Open at full capacity with continued social distancing and frequent sanitizing
- Residents are responsible to disinfect any equipment after use

Billiards Room

- Residents are required to bring their own cue sticks
- Residents must sanitize all billiard balls after use

OTOW will continue to monitor key COVID-19 metrics for Pinellas County. The trend is expected to continue to move in a positive direction. With all residents responsible for their own personal safety and for compliance with the safety protocols for each location, additional facility openings will occur in the near future.
